

## Notice for Chinese, Mongolian and Vietnamese Applicants

1. Chinese, Mongolian and Vietnamese applicants need to present **a certificate** of the conversion of their foreign credentials (school leaving certificate and/or transcript of records of studies) into the German grading system respectively the **certificate of a successfully passed assessment test** from the "Studienkolleg Konstanz" (HTWG Konstanz, Brauneggerstr. 55, D-78462 Konstanz; Phone: +49-7531/206-361, or 206-362, Homepage: http://www.htwg-konstanz.de/index.php?id=107).

2. For an application at the Hochschule für Wirtschaft und Umwelt Nürtingen-Geislingen (HfWU) and for the Studienkolleg Konstanz the following documents are required: the original certificate or the original confirmation that proves the authenticity of your documents issued by the "Akademische Prüfstelle" of the German Embassy (APS)

Chinese, Mongolian and Vietnamese applicants who are already in Germany at the time of applying to a German university are asked to send their documents in certified copy to the responsible APS to have them examined. After having checked the authenticity of your

documents APS will issue a corresponding written confirmation with which applicants can apply for admission at a German university.

## <u>Please note:</u> The Studienkolleg Konstanz will <u>only</u> examine your documents if you present <u>this original certificate or the original written confirmation</u>

3. The APS examination for Chinese, Mongolian and Vietnamese applicants is waived for:

- Chinese, Mongolian and Vietnamese graduates from German Colleges. These applicants have already proved their ability of studying by means of the successfully passed proficiency test;
- Chinese, Mongolian and Vietnamese students who have already passed examinations at <u>German</u> institutes of higher education and wish to change university.

4. Foreign applicants with foreign entry qualification need a proof of a Test in German as a foreign language (TestDaF) with minimum 3 in each category or German language exam for admission to a university (DSH) Niveau 2.

TestDaF can be taken at a licensed test center in your home country. For further information concerning the address of the test centers, the test dates, the application deadlines, the fee, and application form we refer to the internet: <u>http://www.testdaf.de</u>. It is vital to observe the registration deadlines of the test centers.
