## Admission Requirements

Admission to the Examination for External Candidates may only be granted if the following requirements are met:

1. Applicants must have successfully completed a degree program at a German university or a Cooperative State University or hold an equivalent degree from a university abroad. In the latter case, proof is required through a certificate from Studienkolleg Konstanz stating recognition of the degree.
2. Applicants must have had practical work experience of at least one year. Practical experience acquired during the internship as part of the first degree will be counted.
3. Proof of sufficient preparation for the Examination for External Candidates (i.e. attending lectures) must be provided.

The Examination Committee of the Faculty of Business and Law (FWR) at Nuertingen-Geislingen University will make the final decision on whether applicants are allowed to take part in the Examination for External Candidates in the study program in International Tourism Management.

Applicants will be informed in writing by WAF Weiterbildungsakademie at Nuertingen-Geislingen University whether admission to the Examination for External Candidates has been granted or not.

## Cooperation Partners

The study program leading to the Examination for External Candidates in the MBA program in International Tourism Management is carried out in cooperation with **Bodensee Campus GmbH** Constance. The academic director of the program is Prof. Dr. Horst Blumenstock (Nuertingen-Geislingen University); Dipl. Volkswirt Michael Steinbach is in charge of operations at Bodensee Campus. The study program comprises four semesters.

## General Terms and Conditions

### Registration

By submitting this form you apply to take part in the study program leading to the **Examination for External Candidates in the MBA program in International Tourism Management**. WAF reserves the right to deny admission if the maximum number of students has already been reached or if the required deadlines have not been met. **A maximum of 25 students will be admitted. The program takes place in Constance / Lake Constance with excursions to Palma de Mallorca.**

### Payment Conditions

- Tuition fees for the entire study program (4 semesters) amount to **19,900 EUR** (VAT exempt). Fees have to be settled in full upon receipt of the invoice before the beginning of the semester. If fees are not received on time, WAF reserves the right to (temporarily) exclude the student from lectures or to terminate the study contract completely.

The fees are invoiced in instalments:

- 50 EUR handling fee at registration
- 600 EUR upon admission which will be deducted from the tuition fee for the first semester
- Before the beginning of semesters 1 and 2      5,400    EUR respectively
- Before the beginning of semesters 3 and 4      4,550    EUR respectively
- In addition to this, a once-off examination fee of currently 200 EUR will be charged.

### Withdrawal and Termination of Contract

- Applicants can withdraw free of charge within four weeks of receiving the letter of acceptance. If you cancel 4 weeks or more **after** receiving the letter of acceptance, the admission fee (600 EUR) will **not** be refunded. If students withdraw from the program after having paid the first semester fee, an additional cancellation fee of 1,000 EUR will be charged.
- If students register during the four weeks before the beginning of the lecture period, the full semester fee will be invoiced. A free of charge cancellation is not possible in this case.
- If students want to withdraw from the study program, notice must be given at least four weeks before the beginning of the semester. If students withdraw from the program during the semester, the semester fee will not be refunded.
- Notice to withdraw must be done **by letter post** (addressed to WAF) in all cases and not by email or fax.
- WAF reserves the right to cancel the complete study program **before** the scheduled start date if not enough students have registered to ensure economic viability. **WAF guarantees that a study program that has commenced will also be completed.**

### Course and Exam Regulations (EPO)

- The currently valid Course and Exam Regulations (EPO) governing the Examination for External Candidates in the MBA program in International Tourism Management at Nürtingen-Geislingen University shall apply. The complete program comprises 120 ECTS.
- If changes in the EPO are made, some subjects and/or the number of lectures might change during the study program.
